A Community in Action

In vendor payments were expended to help stabilize households in St. Louis County.



15,433 vulnerable individuals with low income received services from CAASTLC helping them to secure or maintain an independent living situation.



Individuals with low incomes received assistance to stabilize their households.





- 13,832 Employment and education support services designed to reduce or eliminate barriers to initial or continuous employment and educational attainment were delivered.
- 1,377 Individuals including infants, youth, parents, and other family members benefited from participation in received case management and family development support to help them to achieve their goals.
- 32,208 individuals received emergency assistance payments to restore utilities, prevent disconnects and prevent evictions and foreclosures.
- 3,057 individuals received emergency services such as food, counseling, and referrals.
- 3,735 Individuals received the opportunity to engage into community engagement and advocacy activities that helped to improve, support, and promote community and individual well-being.
- \$254,442 was paid out to vendors to prevent homelessness for 156 households.

Weatherization and Housing & Support Services



CAASTLC's Weatherization department responded to significant staffing, training, and development challenges in 2023 with determination and focus. The appointment of Keith Robinson as Director, combined with the credentialing of new and existing staff, led to progressive results that addressed the growing needs expressed by the residents of St. Louis County under CAASTLC's 2023 needs assessment.

CAASTLC did not stand alone in the responsibility of providing energy efficient and cost-effective homes in the St. Louis County network. CAASTLC

maintained existing and cultivated new friends in the energy business with community with partners including Energy Stars Heating & Cooling, Affordable Comfort of Missouri, and Earth's Solutions Environmental, LLC. This stakeholder collaboration allowed CAASTLC to further leverage collective public investments with shared service areas and important energy efficient projects in St. Louis County.

One of the distinguishing features of CAASTLC's weatherization program is the attention to the overall health and safety of clients. A testament to this attention is the intervention of CAASTLC's Weatherization Technical Coordinator Dale Hickman. While preparing to complete work for the customer's home, it was determined that her current system would cause a carbon monoxide issue for her business, Granny's House Daycare, which is located in her basement. Because her business was not eligible for CAASTLC service. Dale engaged our friends at DNR and Spire who stepped in to fill the gap. As a result, the facility that cares for children, including those with disabilities received the proper updates, passed fire inspection and was able to open as scheduled.

Community Outreach & Engagement

As part of our strategic outreach initiative to reach more families who experience barriers in getting to CAASTLC's main office, we are collaborating with more local partners to provide more families with utility assistance and weatherization services, and to increase awareness of the services provided by CAASTLC. Our local partners include the Weber Road, Grants View, Jamestown Bluffs, and Florissant Valley branches of the St. Louis County Library, Ferguson Municipal Public Library, Feed My People, Special School District, Ferguson Salvation Army, and Salvation Army Gateway.

CAASTLC's case management team increased its presence in the community by attending the Twillman Elementary Resource Fair, the Overland Parade and Resource Fair, and the Jennings Senior Housing County Workforce Resource Fairs, and having a regular presence at Jennings Place Senior Buildings, River Roads Manor Senior Building, Archwell Clinics, and the Jennings Community Center. Additionally, through its collaboration with partners Ameren Missouri and Spire who provided advertising and staff to help senior families receive assistance, CAASTLC was able to assist over 1.100 households.

Reentry, Employment and Entrepreneurship emerged strong by increasing in-person service delivery for customers in anger management, drug/alcohol, and parenting classes, employment training, hiring events, and entrepreneurship development. Team capacity was increased by the internal promotion of a new Director of Reentry, James Ingram, and the addition of two new Case Managers and an Employment Specialist. Additionally, credentials from the Makin' it Work Facilitator training, Anger Management Institute, STAR Human Trafficking Training, Narcan Training; and participation in the MO Addiction Counselor's Association Conference, MO Association of Treatment Court Professionals, Mental Health Diversion Team Planning, and the MO Reentry Conference have been an added benefit towards customer development.

Participants of the Anger Management classes are taught to identify triggers and employ coping skills to address their anger issues. Participants in Drug & Alcohol classes are taught to recognize triggers and addictive behaviors and how to adapt lifestyle changes to prevent relapses.

Under Employment & Entrepreneurship, CAASTLC coordinated job training and placement, Hiring Events, and Second Chance Job Fairs that resulted in 24 individuals obtaining employment. Three 8-week Entrepreneurship classes provided 15 would-be justice-involved entrepreneurs with an intensive understanding of ideation, business plans, marketing, accounting, entrepreneurial mindset, and hiring/management of personnel. The 13 graduates were referred to Harris-Stowe University's MECCA Entrepreneurship Accelerator Program and received a stipend of \$20.00 per class and as an additional incentive.



Mental Health



CAASTLC's Community Needs Assessment revealed that 84% of all participants surveyed reported experiencing mental health challenges, with the need more pronounced among our justice-involved community. As a result, CAASTLC's Counseling component intensified its efforts by launching innovative programs to ensure our clients receive a methodical approach to intake and meticulous care.

CAASTLC's Counselor created an abbreviated mental health intake assessment to screen all callin or in-person inquiries to swiftly address mental health concerns and improve the collection of crucial data required for direct mental health interventions for our clients, most of whom have minimal access to mental health services. Our Counselor advocates for those affected by the mental health crisis by addressing domestic violence as a quarterly facilitator with the St. Louis

County Domestic Violence Impact Panel. Through these efforts, CAASTLC has become a leader for the improvement of mental health and wellbeing of families in St. Louis County, and we are excited at the prospect of exponentially increasing service for greater community impact.

Providing and promoting equitable access to mental health services is crucial to addressing the causes and conditions of poverty. Low-income families are not only disproportionately exposed to conditions that lead to poor mental health, but also face barriers including accessing quality care, affordability, and stigmatization. CAASTLC recognizes the need for greater access to mental health access services and invites you to be part of our community events that emphasize the need for greater mental health efforts in St. Louis County and those paralleled to CAA's national awareness efforts.

Seeds of Hope Farm









CAASTLC's Seeds of Hope Farm, rooted in Spanish Lake, Missouri is a unique community anchor, growing space, and outdoor classroom that brings joy to the community. This year the farm welcomed a greater diversity of visitors than ever before

for volunteer service, and for hands-on learning experiences that involved elementary, middle and high school groups from Hazelwood School District, Lutheran North High School, Boys & Girls Club of Greater St. Louis, St. Louis County's Center for Youth on the Rise, and Wyman Center, Inc.

Seeds of Hope produced a beautiful and bountiful 2023 crop on 1.8 acres of fertile grounds cultivated by Farmers John, Randy and 12 dedicated community volunteers who contributed 68 hours from planting to harvest.

An abundant yield included bok choy, turnips, radishes, lettuce, chard, onions, sugar snap peas, blackberries, cucumbers, zucchini, sweet potatoes, white and red potatoes, broccoli, collard greens, carrots, cabbage, garlic, tomatoes, okra, parsley, and peppers. Word in the community is that the collard greens were the best – quite sweet and tender. And to our surprise, as students learned of the properties of garlic, they braved eating it raw – and loved it!

In addition to food production, Seeds of Hope addressed the needs of the local community in three interrelated ways. First, we provided information, access, and support to individuals interested in growing their own food. Secondly, families received no-cost access to fresh vegetables, and culinary education that heightened their level of awareness and comfort in adding fresh vegetables into their family's diet. Third and perhaps most important, by providing early exposure to the science and cycles of plant life, Farmers Randy and John helped boost the likelihood of more children achieving academic success and educational attainment as they shared the possibilities of farming and other agricultural careers involving STEM curricula.

Seeds of Hope truly does help people and changes lives. It provides hope for healthier families and communities. Additionally, it offers the opportunity for the community to gather in an outdoor space which lends itself to community engagement and empowerment as we help families "transition from poverty to self-sufficiency for present and future generations".

Before transferring to UMSL, Maria attended St. Louis Community College where, as part of her journey towards obtaining an Associate Degree in Human Services, she engaged in two practicums at community-serving agencies. In selecting a placement for workplace study, Maria came across information about Community Action Agency of St. Louis County, Inc. (CAASTLC). After reading CAASTLC's mission and reviewing its myriad of services, she felt drawn to the opportunity to immerse herself in various aspects of the social work field and to foster personal growth.

Throughout her time at CAASTLC, Maria has come to appreciate the profound disparity between theoretical knowledge and practical application in social work. Navigating the complexities of communication with clients while upholding ethical principles presented a notable challenge, one that Maria approached with humility and a willingness to learn. The prospect of assisting individuals in need filled Maria with a sense of both excitement and gratitude during her interview with CAASTLC. Her primary objective was to gain a comprehensive understanding of the agency's services. Maria felt that CAASTLC's array of resources presented a significant yet rewarding challenge.

My time at CAASTLC has been a source of immense learning and growth, reinforcing my commitment to serving marginalized communities with compassion and humility.
